2022 MTA TRUCK DRIVING CHAMPIONSHIP

GULFPORT, MISSISSIPPI

The Annual MS Truck Driving Championship will be held in GULFPORT – ALL events will be held at the Rented Seaway Road Lot.

APRIL 29 - APRIL 30, 2022.

To be eligible to compete in the Mississippi Truck Driving Championship the contestant must:

- (a) Be accident-free from APRIL 28, 2021 to APRIL 28, 2022.
- (b) Be a full-time truck driver. Spotters, hostlers, etc., are not eligible.
- (c) Shall have driven and performed the duties of a professional truck driver for

12 months for your company prior to entry.

- (d) Live in Mississippi or must operate out of a Mississippi terminal.
- (e) <u>A SAFETY/COMPANY REPRESENTATIVE OF A QUALIFIED ROAD DIVER</u> <u>MUST BE PRESENT A THE TDC TO BE ASSIGNED DUTIES AS A WORKER</u> <u>DURING THE TWO-DAY EVENT. THE COMPANY REPRESENTED MUST</u> <u>HAVE AT LEAST ONE WORKER FOR EVERY FIVE DRIVERS ENTERED</u> <u>FROM THE SAME COMPANY</u>.

*Companies entering drivers must be a member of the Mississippi Trucking Association.

*NEW RULE: A company may enter as many drivers in EACH class of competition as they wish. Drivers may not drive in any class unless his driver's license show that class's endorsement. **ATA Truck Driving Championships rules are followed.

*If a tie occurs, the contestant with the least amount of driving time wins, instead of a drive off.

*Decisions of the judges and the MS Truck Driving Championships Committee are FINAL.

*NOTE: *Once a driver is designated on the entry form to a certain class, he will not be allowed to change to another class!*

Drivers' fees: \$200 per driver: THE REGISTRATION FEE MUST BE SENT ALONG WITH THE REGISTRATION FORM. *NO REGISTRATION WILL BE ACCEPTED <u>WITHOUT</u> THE DRIVER'S FEE*

AGREEMENTS AND RELEASE

In consideration of my being permitted to participate in the ATA's National and/or its affiliates' Truck Driving Championships (TDC) or Step Van Driving Championships (SVDC) and be eligible for awards offered to participants, I hereby stipulate and agree to the following:

- 1. I acknowledge that I am not in the employ of ATA or a State Trucking Association.
- 2. Both as to myself and my heirs and personal representatives, I release ATA, its directors, employees, agents and/or any of its affiliates and the State Association noted above, its directors, employees, agents and/or any of its affiliates from any and all liability and any right of action that may arise from any damage or injury which I may receive while attending or participating in said State or National TDC or National SVDC.
- 3. I grant the State Association listed to the left and ATA and its designated agencies exclusive right to make use of information about myself and of photographs supplied with this entry form, along with photographs subsequently taken under ATA's direction, in publicity and advertising activities. I further agree to make myself available for publicity enterprises arranged by ATA, with newspaper and magazine writers and radio and television personnel.
- 4. I grant State Association listed to the left and ATA the right to examine my CDL and MVR for the purposes of determining my eligibility to compete at both the State and National TDC or SVDC.
- 5. I will be bound by all orders, rules and regulations governing ATA's National and/or its affiliates' TDC or SVDC while participating in said competitions.

CERTIFICATION BY CONTESTANT. I certify that:

- 1. I have been continuously employed as a truck or step van driver by my present employer since August 15, 2021.
- 2. I have driven and performed the regular duties of a truck or step van driver since August 15, 2021.
- 3. I have not been away from the regular duties of a professional truck driver beyond an aggregate of 30 calendar days since August 15, 2021.
- 4. I have not been involved in a fleet motor vehicle or motor carrier vehicle accident since August 15, 2021.
- 5. I have the proper class CDL or DL plus required endorsement(s) for the class of competition indicated to the left.
- 6. I hold a CDL (DL if SVDC) from or have been occupationally domiciled in the state of Occupational domiciled is defined as the terminal, garage or other operating base from which the driver normally works, is supervised and/or where employer is corporately headquartered.
- 7. I have not received any form of pay, bonus, prize or other consideration for time spent in practice as set forth in the Truck Driving Championships Rules & Procedures. I agree that if I compete and win the State TDC, that I will compete at the National TDC or SVDC (as applicable), unless disgualified or am detained due to a medical emergency, in which case I will notify the applicable State Trucking Association immediately. I acknowledge that any misstatement made with respect to my eligibility for the TDC or SVDC competition may result in the forfeiture of my right to compete or in my disgualification from said competition.
