Founded in 1942, the Mississippi Trucking Association is a non-profit corporation operating as a trade association. MTA represents the Mississippi motor carrier industry in the advancement of highway transportation and serves as the "Voice of Trucking" in this state. The Association maintains headquarters two blocks from the State Capitol in Jackson, Mississippi. It conducts activities for the improvement of trucking services to the public and sponsors programs in the public interest for the betterment of the trucking industry.

MTA represents an industry that is the sole transporter of consumer goods and manufactured products to most of the state's communities. Our membership consists of more than 300 member firms that include for-hire and private truck operators and allied industry members (those that equip and service the industry).

LAWS AND REGULATIONS

Few organizations can boast of the legislative success enjoyed by MTA. This was accomplished by a strong and determined membership and by harnessing numerous resources and friends of the industry. Making sure that laws affecting truckers are fair and equitably administered is one of the main functions of MTA. Truckers are represented every day during the legislative session and throughout the year before special committees. The committees listed below handle most trucking legislation and MTA maintains a special relationship with them.

- Incumbents whose voting records prove they are sensitive to the needs of the trucking industry.
- Candidates who indicate support for business-oriented issues.

CONGRESSIONAL

The MTA staff and other officers make periodic calls on each member of Mississippi's Congressional Delegation. Special trips to Washington, D.C. are made when necessary to inform our delegation of truckers' views on pending legislation.

The concept of the program is to combine members' premiums to pay each other's claims. Money not needed to pay claims or operating expenses is returned to the member in the form of a dividend. ACCOMPLISHMENTS

Although legislative activities are just one important phase of MTA's purpose, many prospective members prefer to judge an organization by its success in that area. Listed below are only a few legislative achievements of MTA in recent years:

- Sales tax exemption for truck tractors and semi trailers used in interstate commerce
- Tort reform
- Protection to motor carriers with respect to owner/operators and their drivers under written or oral lease for job related injuries
- Abolishing Ad Valorem taxes on truck tractors
- Increased state weight limits from 73,280 to 80,000 pounds
- Allowing credits on over payment of fuel taxes
- Abolishing Ad Valorem taxes on semi trailers
- Reducing sales taxes on semi trailers from 6% to 3%
- An exemption for certain pre-approved carriers from having to stop at weight stations PrePass
- Approval for MDOT to enter into agreements with contiguous states to operate duel ports of entry two states one stop weight station
- Authorization for the state to offer \$65 trailer tags
- Increased overall length and width of equipment permitted to operate in Mississippi to 53 feet long and 102 inches wide
- Changes in oversize/overweight regulations and permitting allowing for additional nighttime travel and easing
 of certain height/weight restrictions

Every state trucking association has its own set of anti truck legislators to deal with and MTA is no different. How motor carriers operate today in Mississippi is based, to a great extent, on how effective MTA negated their efforts. Below are a few punitive legislative proposals killed through efforts by MTA:

- 1. Ton-Mile taxes ranging from five cents to nine cents per mile, killed in legislature five times
- 2. Numerous attempts to raise fuel taxes
- 3. Legislation to levy additional fees and taxes on trucking by local governments

Through the cooperation of a committed membership, the Association's Headquarters is strategically located near the Mississippi State Capitol complex.

The operation of a safe and reliable fleet is the obligation of every motor carrier. The Mississippi Trucking Association has two Councils that play an important role in helping member fleets accomplish that.

The Safety Council is in place to help carriers stay current on constantly chaning DOT regulations as well as work to help make sure each carrier has an opportunity to have the opportunity to have a solid safety program through workshops, monthly meetings, networking and Carrier and Allied member cooperation. It also provides for an excellent opportunity for the enforcement agencies and carriers to work together to insure both parties are well informed to minimize unnecessary conflicts and delays. The Safety Council also manages the annual Truck Driving Championship each year.

The Council of Maintenance Supervisors provides members with the opportunity to bring fleet maintenance professionals together to share in best practices as well as opportunities for Industry Suppliers a venue for providing the carriers with the latest in training and new product development. The Maintenance Council is also active in working with

technical training institutes to provide students looking to enter the market with a conduit to connect with member companies. Opportunities for skills competition are in place to encourage the constant improvement of today's technicians.
